5	Care Unit	<p>A public consultation on the future of Uig Care Unit was held on Monday March 18th at Uig Community Centre.</p> <p>There was a good turnout for the meeting and the strength of community opinion was made clear. Responses to the consultation were required by Wednesday 20th March, giving just one day for the public to formulate and post off their views. However, on 20th March it was announced by Western Isles Integration Joint Board (IJB) that the consultation period had been extended until 26th April.</p> <p>Members agreed that it is extremely important to make the community's views known and hoped that the extended period would enable some good response.</p> <p>CMacK has written to SMP Alasdair Allan, but has had no acknowledgement to date. CMacL has also sent a letter and understands that Mr. Allan has written to the IJB.</p> <p>CMacL will put copies of the consultation form into the doctors' surgery and LD will put copies into the shop.
