7	<b>Community Conversations</b>	<p>A further meeting in Uig, this time regarding Transport Services, took place on 25th June. Following this round of consultations, elected members of CnES unanimously agreed a redesign process. 8	<b>Uig Community Consultation</b>	<p>SB had forwarded a condensed report on the Consultation meetings that took place at Uig Community Centre on 30th May. A list of comments coming out of the Consultation and tabulated to show numbers of votes cast for each suggestion, was circulated to UCC members.</p> <p>AM was asked whether there was any news on Uig Care Unit - apparently there has been no decision to date and there is more consultation to take place.</p> <p>The draft Uig Development Plan is due to be completed during July.</p> <p>As there are many areas of similarity and crossover between Community Conversations and Uig Community Consultation, AM requested that SB should share all comments and updates with Alice Murray to allow for greater tie-in of the projects.</p>		
9	<b>AOCB</b>	<p>WG enquired whether there are any plans to reinstate the white lines where road resurfacing has been carried out. This does not fall within the plans for the current round of roadworks.</p> <p>Suggested there could be more notices on the roads regarding giving way/overtaking on single-track roads.</p>
