- Matters Arising**
- 8.1 **Callanish Post Office** – Simon Butler advised: “Since the last community council meeting, plans to locate the post office at Calanais have moved forward significantly. We have met with the Post Office Project Manager on site to agree the location of the counter, along with the various other behind the scenes work that will be required. Training dates for the staff have been set, and we are now arranging for quotations for the necessary work to be undertaken. All being well, we anticipate that the Post Office at Calanais will be open in early February 2020. We will be holding a public consultation meeting to update the community on plans for the Post Office on December 3rd. This will be advertised through newsletters, and on social media very shortly”.
