Inauguration of New Community Council

Derek MacKay, Governance and Election Manager responsible for the election and set up of Community Councils opened the meeting by first explaining what a Community Council is for and how it is to serve the community. Derek explained that there is a Community Council info folder on the Comhairle website that provides information and guidance on the various roles and responsibilities of community councils and regulations regarding GDPR as well as guidance on the use of social media.
