i) EDF Ward Funding Application

An application request for ward funding & CC assistance was received for the festival, due to a shortfall in funding. The festival is due to take place at the end of July.

Following discussion, it was decided that BCC would be happy to award £500 to the festival, and would support the award of £1000 from Ward Funding. Suggestion that assistance from other CCs in the Uists would be appropriate as the festival will provide a community benefit to all areas

 Secretary to request that the ACC write to all Uist CCs to assist the festival to reduce the shortfall in funding

CC MacKay was invited to rejoin the meeting

ii) CC MacCormick raised a query on the ownership of the shed at market stance. Roof works have been ongoing at the building, which could be utilised, but ownership is unclear.

The Torlum School building was also discussed due to the dangers of the fabric of the building.

- Secretary to write to CnES Technical Services to clarify ownership and responsibility for the upkeep of these derelict buildings
- iii) It has been noted that roadside grass cutting remains an issue
- **iv)** A recent accident on the North Uist causeway has highlighted the safety of this road. BCC considers that the installation of chevron warning signs on the road could prevent accidents in the future.
