- Torlum School awaiting further update from CnES (Tech Services expected to be initiating works soon). CnES staff members / Community Members need to raise access issues in relation to H&S direct with CnES as an employer / owner of property.

C'llor Walker will raise questions regarding access for CnES employed staff.

An application has been received from Tagsa Uibhist for a Christmas Party/Burns
Supper Event. £500 was requested from ward funds toward this event

- BCC informed that £60k from the crash of the oilrig off-coast in Lewis is to be spread across the Western Isles. Consideration to be given to possible projects that could utilise funding,

- Balivanich School Trip: Suggestion made to assist Balivanich Schoolchildren with a likely shortfall of funds for the P7 trip to Dalguise, noting ward funding requires to be allocated by Jan 2017.

- Streetlights: Request lights to remain on in key areas across Benbecula between 16th December & 16th January

Sheena Stewart presented statistics to the group which outlined that North Uist
& Benbecula show very poor outcomes in relation to child poverty, positive destinations and depopulation when compared with the rest of Scotland.
OHCPP recommend that concentrated locality plans are required to support the poorest areas.
