# 3. Minutes of Meeting of 5<sup>th</sup> July:

Approved Linda, seconded by Gail.

# 4. Matters Arising from Minutes of 5<sup>th</sup> July Meeting:

Donation, Seating Bench: Gail continues to liaise with family and Planning Dept.

**Balivanich Regeneration:** public meeting scheduled for 20<sup>th</sup> September.

**Old Bakery:** Gail in discussion with owner of land/property, Bill Hogg.

Youth Café: BCC Grant now paid into their bank account, recently opened.

**Planning Application, Caravan, East Camp:** Clerk informed by planning Dept that application withdrawn.

Lord Lieutenant: email to chair of the Association of Community Councils. Reminder sent by Clerk.

**Play Parks:** C'llor MacKay is Comhairle contact. The Comhairle will remove old or damaged equipment if requested.

Izabela Doyle updated BCC on Balivanich PlayPark developments after recent AGM. Over £60k has been raised by this committee to date, and fundraising continues to purchase more equipment and consider work required to reinstate football pitch, estimates likely to be in region of £100k. PlayPark Committee also planning to have Xmas tree and lights for Xmas display.

The Chair thanked Izabela and PlayPark Committee for all their efforts and achievements to date.

**Grass cutting Old Primary School:** Meeting informed that this building has now been sold. Hugh informed the clerk that not safe to use machinery in this area. Cutting grass verges in public roads

discussed. Gail has discussed this with local police (safety, signage, vulnerable areas at road junctions), and awaiting a response.

## 5. Treasurer Report:

Treasurer absent from meeting (Stornoway), no report. Little change from previous meeting:

Bank balance stands at £6226.46 as at 31<sup>st</sup> May. Successful audit resulted in annual credit of £1000 from the Comhairle. Grant to Youth Café now paid.

#### 6. Correspondence (Clerk):

# 6:1 Balivanich Road Safety, Petition.

Cheryl Poole active in this matter, and apologised for absence, due to work commitment.

C'llor Roddy MacKay presented Petition with 147 signatures, mostly local, requesting Zebra Crossing on main road entering Balivanich at the BnC/Tindill Rd crossing, used by school children and public. C'llor MacKay has already discussed with Technical Services Calum MacKenzie and will deliver Petition to Director, Iain MacKinnon next week.

Additional road safety concerns were discussed, many already referred to Technical Services: Smiley Face signage, White lining Nunton on approach road "SLOW", illegal car parking Tindill Road, footpaths Nunton and Balivanich to East Camp, bus shelter East Camp, street lighting to extend to East Camp.

AGREED: Clerk to write to Director of Technical Services itemising all these issues, many of historic concern, already raised by Benbecula Community Council. C'llor MacKay will present Petition to Director next week. Copy of Petition with Chair.

# 6:2 Community Board, CalMac

Gail is now a member of this Board, and reported on recent meeting she attended in Mallaig, as follows:

Meeting with David MacBrayne Board proposed and agreed.

As no record can be kept of missed or potential bookings to establish demand yet we asked when the booking system would be upgraded. We were told that this would not be up and running until 2020 at the earliest.

Record keeping of bookings requested but still no record kept of missed or potential bookings. This data will be kept in future, but not until 2020!

Easter disruption to sailings. Report from CalMac still awaited.

Notices on ferries of Board membership ... often these are covered up by other material. This to be rectified. New notices to be put up on vessels and at port offices with new Board Members details on. These will be sent out asap and Calmac Staff to be informed as to the Community Boards remit so that they can work with the Board and Customers going forward.

Chair of Board, Angus Campbell has requested meeting with Islands' Minister, Paul Wheelhouse MSP

Ferries 10 Year Plan .... Need to ensure 5/10 Year Plan discussed and commitment of investment agreed with Scottish Government.

Public consultation on Pier Infrastructure proposals .... Public Meeting at Lochmaddy planned.

Ferries Users' Group expressed concerns that "operational issues" not being addressed by CalMac... the Community Board was not established to deal with operational matters.

Next Meeting of CalMac Community Board is in Glasgow on 16<sup>th</sup> November. Minutes of these meetings can be accessed online.

Agreed: Clerk to write to Islands' Minister and Transport and Infrastructure Minister on Ferry concerns, including recent disruptions on Skye Triangular sailing route and also Lochboisdale/Mallaig Easter cancellations, and delay in new ferry delivery date.

#### 6:3 Police Scotland Focus Group Meeting.

Meeting cancelled, training staff plane cancelled. Awaiting rearranged date.

#### 6:4 Benbecula Flag

#### 6:6 Harvesting of Kelp

Details of proposals circulated by Clerk prior to meeting.

Agreed: Clerk write to Planning Dept expressing strong objections to these proposals on grounds of environmental and ecology considerations.

## 6:7 Griminish War Memorial, Wreath laying receptacles

Communication from C'llor MacLeod refers to this item. Some basic work required to maintain wreaths in situ during adverse weather. Clerk informed the Meeting that Hugh MacCormick kindly agreed to accept responsibility for this matter, and will contact others as appropriate.

Two applications discussed and agreed as follows:

# 8:1 Amie Ringstead, Girls' Basketball Team, Inverness Lions

Help requested for cost of travel and accommodation for minimum of 17 trips to Inverness, total cost of £4000-£6000. Grant of £1500 from Sport Scotland. Additional details on Application.

Agreed £500 from Benbecula Community Council. Also, C'llor Roddy MacKay to consider Ward contribution with two other councillors. Gail to inform family. Any councillor contribution should be paid via BCC account.

#### 8:2 Adam Keltie on behalf of Cuimhne Armchair Athletics.

This is to support school pupils travelling to residential care homes to engage with activities with care home residents, programme already established. Basic cost of transport to be met.

Agreed £250 from BCC and C'llor Roddy MacKay to pursue £250 from each of Ward 2 Councillors.
