## **Matters Arising**

### **Brevig Harbour Users Group**

Gordon and Alex John kindly attended our meeting;

- Made yellow tags to attach onto the equipment that will be disposed of, to make the owners known to the committee by a certain date.
- Spoke to McLaughlin Plant who agreed to take away the wrecked boats, creels and scrap steel, provide skips.
- Alex John Talking with Environmental Health who promised the provision of skips and discussed a community clean up day
- Will provide a notice of 4-6 weeks, to have a harbour clean up day in January 2022.
- Received £22.5k from the Crown Estate
- Ivor Murrays are contracted to carry out work on safety rails and corners quoted £8k.
- The harbour area is getting worse the Comhairle owns Brevig pier so the Harbour master is responsible. Check the terms and conditions of the use of harbour. There is no enforcement.
- Possibility of a further £22.5k in next year's round of funding.
- Progress Mclaughlins have begun breaking scraps.
- If there is a skip charge, our councillors will pay this out of their ward funding.

## **Development Worker**

There was one unsuitable applicant for the development worker post who did not meet the criteria. Cllr Crichton suggested that we wait until January and get a consultant on board. Andrew will forward the job description over to Colin

#### **Polycrub**

Colin will get updated quotes for the polycrub and materials.

- Similar to one in Pitlochery but on a smaller scale
- Open woodland walk to the public next year
- Scotland's Garden Scheme
- Honestly box small entrance fee good for local community
- Environmental benefit. Renewable energy, water and wind powered, solar power. Suggesting off-grid kit.
- Community energy grant
- Crown estate Work on the costing and submit a funding application for the next round.
- All agreed it is a great idea, will be fantastic for families and children
